**Animal Rescue League of Boston
Fundraising Commitment, Waiver
and Release Agreement**

Thank you for raising funds on behalf of in the Animal Rescue League of Boston (ARL). Please carefully read the following User Agreement, which sets forth the terms and conditions. By signing this document you are agreeing to all provisions, implied or otherwise, of the waiver.

FUNDRAISING COMMITMENT

I understand that all the donations that are raised through my fundraising efforts will be designated to the Unrestricted Fund at the Animal Rescue League of Boston and cannot be assigned to any specific program or cause unless otherwise agreed upon in advance.

CANCELLATION POLICY

I understand that I may cancel or suspend my fundraising efforts on behalf of the ARL. Any donations I raise on behalf of the ARL before my cancellation will be refunded to donors or given to the ARL.

BRANDING

I understand that “Brand” includes all typefaces, colors and other physical and visible characteristics used in renditions of the ARL’s logo, labels, mastheads, images, etc. I may use materials with the ARL’s Brand only in connection with my fundraising on behalf of the organization. I understand that to receive an ARL logo for use on marketing materials, I must make the request **a minimum of 30 days** in advance of the event and provide marketing material to Ami Bowen, Director of Marketing and Communications, for approval **a minimum of 15 days** prior such use. I understand that the name of the organization is the Animal Rescue League of Boston. I will use only this name or its approved abbreviation, ARL, in all fundraising communications.

WAIVER AND RELEASE

In consideration of ARL accepting this document, I hereby for myself, my heirs, executors, and administrators, waive and release, and agree to hold harmless, the Animal Rescue League of Boston, its employees, volunteers, officers, and sponsors from any and all claims for any and all injuries or damages suffered or sustained by me in conducting fundraising on behalf of the organization.

I hereby give the ARL (including its affiliates, successors and licensees) the irrevocable right to use my name, voice, likeness, image, biographical information, and/or picture, in any and all promotional, marketing or other publicity of ARL, including without limitation any video images and audio recordings of me, in all forms and media now known or hereinafter created (collectively, the “Materials”). I hereby waive any right to inspect or approve any uses that may be made of the Materials. I agree that the Materials shall constitute the sole property of the ARL, with full right of use and disposition in any manner whatsoever. I hereby completely release, discharge, and agree to hold harmless the ARL from any and all claims I may have relating to its use of the Materials, including without limitation defamation, right of publicity and invasion of privacy.

By signing below, I certify that I have read, understand and agree to the terms of this agreement, including but not limited to the fundraising commitment and Waiver and Release above. I further certify that I have exercised my own judgment in signing this agreement and that the decision to sign this agreement was voluntary and not based on or influenced by any promise or other representation from the Animal Rescue League of Boston.

If I am under 17 years of age, my parent or legal guardian also certifies they have read, understand, and agree to the terms of this agreement, including but not limited to the fundraising commitment and Waiver and Release above.
