EVERY ANIMAL THAT COMES TO AN ARL SHELTER RECEIVES A MEDICAL EVALUATION FROM ONE OF OUR HIGHLY-QUALIFIED, CARING SHELTER VETERINARIANS. OUR TEAM MEMBERS CONTINUOUSLY TRAIN AND WORK TO EXPAND SKILLS TO MEET THE NEEDS OF A DIVERSE RANGE OF SPECIES INCLUDING DOGS, CATS, RABBITS, SMALL ANIMALS, BIRDS, AND LIVESTOCK, COMING FOR A VARIETY OF LIVING SITUATIONS AND CONDITIONS. 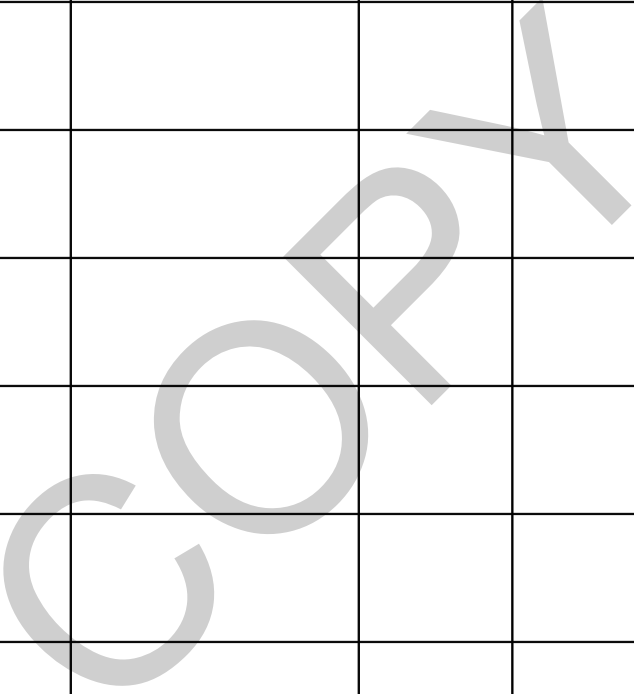

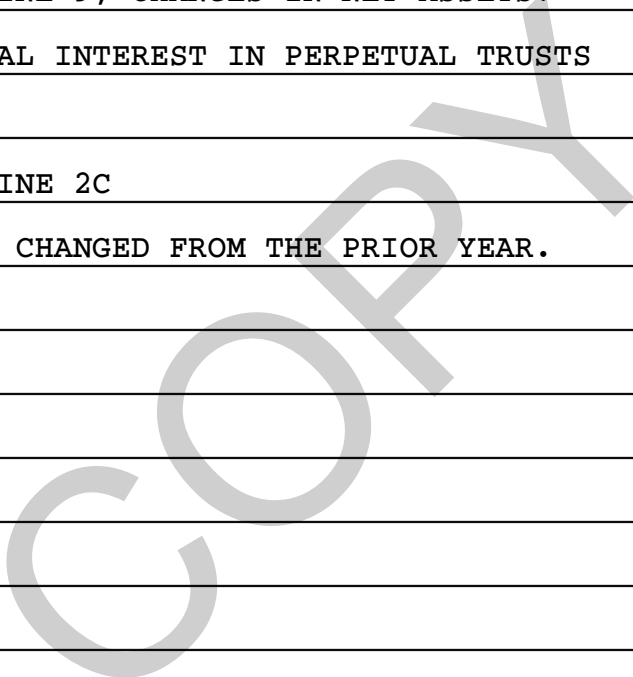
