



Dennis Animal Control Officer Lori Miranda Named “ACO of the Year”

Dennis, MA – The Animal Rescue League of Boston (ARL) and the Massachusetts Society for the Prevention of Cruelty to Animals (MSPCA) are proud to announce that Dennis Animal Control Officer (ACO) Lori Miranda has been named Animal Control Officer of the Year for 2021.

ARL and MSPCA established the ACO of the Year award to honor an animal control officer whose efforts in their local community throughout the year have promoted responsible pet ownership by:

- manifesting a dedicated, humane attitude toward the treatment and well-being of all animals
- effectively enforcing pet responsibility laws
- conducting public awareness and humane education programs
- maintaining cooperative working relationships with other agencies involved with animals, such as state and local government departments, other ACOs, and animal protection groups

The award was presented Friday, October 29, at the annual banquet held by the Animal Control Officers Association of Massachusetts.

Officer Miranda’s nominations for ACO of the Year included a number of accolades, heralding her dedication to animals and community, professionalism, and compassion.

Officer Miranda has been Dennis’s ACO since 2010, and has consistently demonstrated dedication and compassion for both wild and domestic animals in distress throughout the community. With the Cape Cod population swelling to over 50,000 people each year, she sees a significantly increased workload and always addresses situations with compassion and care.

In addition to enforcing the local bylaws, she engages in animal safety campaigns and finds homes for animals in need. She speaks to civic groups, is a member of the Cape Cod Hoarding Task Force, and maintains the local dog park.

“Officer Miranda has served the Dennis community for more than a decade with absolute dedication and it is truly an honor to recognize her as our Animal Control Officer of the year,” said Joe King, ARL Law Enforcement Director.

“We are excited to recognize Lori as the ACO of the Year. As someone who worked with her for many years, we know firsthand her dedication and her compassion. She exemplifies the traits ARL and MSPCA look for each year in an ACO,” stated Kara Holmquist, director of advocacy for the MSPCA.
